

## **European Chemicals Regulation (EC) No 1907/2006 (REACh)**

To whom it may concern,

the EU Chemicals Regulation (EC) No 1907/2006 on the Registration, Evaluation, Authorisation and Restriction of Chemicals has been in force since June 2007.

REACh affects practically all sectors of Industry and assigns defined roles and obligations to the participants in the supply chain.

We at Heinrich Kipp Werk KG confirm that we are familiar with our obligations regarding REACh.

As an EU-based manufacturer and supplier of clamping tools, standard elements and operating elements that constitute products in accordance with the aforementioned regulation from which no substances are released under normal usage conditions, we ourselves are not subject to any obligation for registration of substances and preparations.

We have instructed our sub-suppliers regarding their obligations in connection with REACh. In close cooperation with them, we will ensure that no bottlenecks or interruptions of the supply chain can occur.

We hereby confirm that, according to the current status of appendix XIV of the regulations, to the best of our knowledge, none of the substances listed therein are used as alloy materials or additives in the manufacture of our products.

## **SVHC substances / Information along the Supply Chain (article 33):**

On June-27-2018 Lead (CAS No: 7439-92-1) had been added to the Candidate List.

Currently Lead is present in many of our product components as an alloy element of free cutting steel and brass.

The use of these products is furthermore permitted and safe.
